Robert M. ("Bob") Gordon is the President and owner of Loudoun Commercial Title, L.L.C. ("LCT"). Loudoun Commercial Title is a title insurance agency which provides a full range of due diligence, title insurance, and settlement services in Virginia, Maryland, and the District of Columbia. Bob is admitted to the practice of law in Virginia, Maryland, and the District of Columbia.

Bob Gordon is an attorney with over 35 years of experience in business, finance, and commercial and residential real estate transactions of all kinds.

Bob attended the University of Colorado, graduating in 1973 with a double major in History (Summa Cum Laude) and Russian. Bob attended Georgetown University Law School and in 1978 received a law degree (JD) and a Master's Degree in Foreign Service. He served on the Editorial Board of the Georgetown Law Journal.

After graduating from law school, Bob served as a judicial clerk to the Hon. Thomas A. Flannery, United States District Judge for the District of Columbia.

In 1979 Bob began his tenure as an associate and partner at the law firm of Shaw, Pittman, Potts & Trowbridge (now part of the firm Pillsbury Winthrop Shaw Pittman). During his 21 years as a business lawyer at Shaw Pittman, Bob concentrated on transactional real estate, finance, and land use matters, representing a wide range of real estate investors and lenders. This included significant work in connection with workouts, foreclosures, and bankruptcies during the real estate recession of 1989-1994. Bob served as the Chairman of Shaw Pittman's Finance Committee, responsible for overseeing billing, collections, financial systems and reporting, audit matters, tax returns, and finances for a major law firm.

From 1999 through 2001 Bob served as General Counsel to the Washington Redskins, handling a wide range of business, financial, and legal issues for the Redskins. This work included trademark, intellectual property protection, sponsorship and marketing agreements, television and radio contracts, dispute resolution and litigation, workers compensation and employee matters, and NFL compliance issues, in addition to normal corporate and financial matters.

During 2003, Bob Gordon was engaged in a full time political campaign for election as Chairman of the Board of Supervisors of Loudoun County, Virginia. Bob was successful in obtaining the Republican nomination for Chairman, but lost (by less than one percent) a hotly contested three-way general election to the incumbent. After the election Bob opened Loudoun Commercial Title, L.L.C.

From January 1, 2004 until the present, Bob has been the President and owner of Loudoun Commercial Title, LLC, a real estate settlement and title insurance company. During this time, Bob has handled and closed several thousand real estate transactions ranging from simple residential or commercial purchase and sale or refinances, to complex commercial transactions as large as \$150 million. Through Gordon Law PLLC, Bob engages in the practice of law and regularly is involved in purchase and sale of residential and commercial properties, documenting and closing financial transactions, the analysis and clearing of problems relating to

title to real property, and expert witness engagements, including research, analysis, and resolution of lien claims, lien priority issues, and title questions of all types.

Bob is also part owner of Loudoun Insurance Group, a full service independent insurance agency headquartered in Leesburg, Virginia.
